## FROM THE COORDINATOR'S DESK

#### It is 2023 already!

As travel opened up last year, life seems to have gone back to the 'old' normal in many ways, instead of the much hoped for 'new' normal where we would have more investment in public sector and health services, greater awareness of the importance of frontline and health workers, better support for women involved in relentless unpaid labour and a deeper knowing of the massive interconnectedness of all our lives on this one planet that we share.

We witnessed human beings and social structures at their best in developing a vaccine at super speed but then falling back on the old power dynamics which meant Europe got the vaccine faster and cheaper than Africa could.

We had many countries take up telehealth for medical abortion and retain those systems post pandemic while we had the Taliban takeover Afghanistan and stop girls from studying beyond 6 th standard.

ASAP members and partners and allies everywhere showed up with courage and resilience and a capacity for rising to their highest and best selves like the champions they all truly are.

We conducted out first hybrid YAI in Karachi in May, the first in-person YAI and YAR in Kathmandu in June and then went on to organize 7 more before the year was out. As much as we love our virtual spaces that allowed us to be more inclusive, we delighted in being in the same physical spaces.

## FROM THE COORDINATOR'S DESK

Sharing positive energies and those informal conversations where sometimes the golden nuggets of learning can be found even more so than in the planned sessions!

The pandemic caused an explosion in online engagement and we realized that safe abortion rights activists, advocates and defenders needed to step up our game and look into online safety issues that we face with every tweet, every search and every email.

We also worked proactively to continue to build an inclusive movement and deepened our work with the deaf and hard of hearing community and transmen across the region.

A play turned into an online performance, a stage performance recorded as a video and videos reflecting ethnographic research were also the amazing and creative highlights of the past year.

We look ahead at an even more eventful year as we start to revitalize the network and the safe abortion rights movement in the region and we thank you all for being with us on this journey.

A famous couplet by a much-loved Urdu poet from India, Majrooh Sultanpuri, reminds us that it is not just the power of the one who starts the journey towards a goal, but the collective power of each one who joins in and contributes towards building a movement.

# ASAP ACTVITIES

#### **Shaping Safer Online Spaces**

Through our strategy for <u>Shaping Safer Online Spaces</u> we have taken the initiative to explore and understand the safety, security and censorship issues involved in the multiple online platforms that all of us use as advocates, providers, users and activists in sexual and reproductive health and rights.

We are seeing a global trend of increasing suppression, silencing and threats being faced by those who speak out against oppressive regimes or conservative politics and highlight the violations faced by vulnerable communities.

We also know that those who own and manage the various platforms can, at the behest of the governments, limit our rights to freedom of expression and free speech thus silencing us overnight and leaving those who depend on us for information and support helpless and lost.

As leaders in the SRHR and safe abortion rights movements, it is our responsibility to be aware of the risks and start to work on reducing harm, protecting our data, responding to threats and ensuring the safety of the service seekers.

The first step we undertook for this was to conduct a global survey earlier this year with key stakeholders in our field of work, which gave us very valuable insights. We are currently working on a guidebook for addressing and managing issues like cybersecurity threats, hacking and trolling.





# The Amazing Flabby Breasted Virgin & Other Sordid Tales | February 2022



ASAP in collaboration with KathaSiyah, held the first screening of their play this year, which has been in planning and was inspired around two years ago from the writings of Coordinator Dr Suchitra Dalvie (Being a Feminist Gynaecologist in a Patriarchal World). The article inspired Ayesha Susan Thomas, who is Theater Practitioner, Teacher and Co-Founder of KathaSiyah to write a play based on the perspective of how medicine services the patriarchy by modifying and controlling women's bodies.

The Amazing Flabby–Breasted Virgin & Other Sordid Tales is a playful, irreverent digital performance. This performance is part of an educational arts project on systemic issues in both medicine and education today. It plays with the myths and magical thinking that surround and define the non– masculine, non–heterosexual body. It poses surreal and satirical questions about how women's bodies are taught, perceived and practiced within medical education in the urban Indian context.


## Building Inclusive Movements | ASAP with CANs


#### Focus Group Discussion with deaf and hard of hearing community

Our Pakistan CAN organized the first ever national YAI in the country, which also had the distinction of being the first hybrid YAI ever organized by our network. Due to restrictions in traveling, the ASAP team joined the workshop via Zoom video conference over the 3 days. It was attended by 21 participants from across the country, from different fields of work like lawyers, doctors and civil society organization representatives.



#### Training on Safe Abortion Rights | Women For Change | 21st – 22nd September | Ulaanbaatar, Mongolia



ASAP in collaboration with WFC, organized a 2 day hybrid workshop on safe abortion rights in Mongolia. ASAP Coordinator Dr Suchitra Dalvie and co-founder of MASUM, our regional partner Manisha Gupte facilitated the sessions via Zoom, starting with an understanding the politics of patriarchy and it's linkages with the right to safe abortion. The 2nd day was led by the WFC team, focussing on the local challenges, concerning SRHR and safe abortion access in the country and how they can be countered.

#### International Safe Abortion Day: Make Safe Abortion Certain | 28th September | Online


This year we focussed on the global theme of 'Abortion in Uncertain Times' along with our own perpective, that anyone who needs an abortion is really facing uncertain times.

#### Demanding Right to Safe Abortions | SAMA | IWD'22


## Evidence in Action: Making the case for investing in SRH | Guttmacher Institute | ICFP | 16th November | ICFP Pattaya, Thailand

Coordinator Dr Suchitra Dalvie was invited as a panellist for this side event of ICFP where she spoke about the importance of data and why it needs to be looked at from the feminist perspective. She also highlighted that as human rights advocates we should be wary of generalisations based on mere statistics and always keep in consideration the rights of an individual along with the local cultural context of each country and its intersectionalities.



## De-Mystifying Self - Managed Abortions: What it takes to put Misoprostol in Women's Hands | Fos Feminista | 15th November | ICFP Pattaya, Thailand

Assistant Coordinator Nandini Mazumder represented ASAP as a panellist on this session which aimed to 'de-mystify self- managed abortion through a 'choose your adventure' exploration of strategies for making safe abortion self- management a reality in low resource settings. The session busted various myths that restrict the progress of reproductive rights and answered questions around self- management along with addressing the political strategies required to ensure people have this right to choose.



#### Call to Action for Safe Abortion Rights | ICFP | 16th November | Pattaya, Thailand

In the aftermath of Roe vs Wade, ICFP released a 'Call to Action', demanding Governments, funders and the international community to urgently stand up for abortion rights across the world. Dr Suchitra Dalvie represented ASAP as a panellist and on behalf of South, South-East and South – West Asia endorsed and supported the call to action.



#### **CALL TO ACTION**

We call on governments, donors, and the international community to urgently stand up for abortion rights by taking the following action:

1. Ensure universal access to person-centered abortion care for all including young people, through a comprehensive range of pathways to care that maximizes choice, including access to quality medical abortion commodities and opportunities for self-managed abortion, MVA and in-facility care, and access in humanitarian settings.

2. Decriminalize abortion and create a supportive environment for abortion care, including countering organized opposition and harmful conversative norms through strong and coordinated advocacy movements.

3. Provide responsive and long-term funding for abortion care that supports innovation, strengthens health systems and creates sustainable change, including support for civil society and grassroots movements.

4. Recognize abortion as a human right and ensure that abortion is mainstreamed in all SRHR, health, and human rights programs, including integration within Universal Health Coverage and broader health systems.









## ASAP AS PARTICIPANT

#### SheDecides + 5 Conference | Brussels | 19th - 20th May



Coordinator Dr Suchitra Dalvie who is the She Decides Champion for Asia Pacific, attended the SheDecides + 5 conference in Brussels which saw representation from various organizations individuals working on SRHR but also from the Belgium Government who through this conference reaffirmed their support to the SheDecides movement.



#### Why Digital Rights Are Reproductive Rights | Women's Link Worldwide | 12th May | Online

Communications and Network Officer Ayesha Bashir attended this webinar which had panelists from organizations like Article 19 & Women on Web speaking about increased restrictions on online information sharing and how collectives are overcoming challenges being faced due to tech platforms like Facebook or Youtube which are taking down their accounts, for 'going against their community guidelines'.

This was an important discussion, as ASAP too has faced similar barriers online and we too are currently working towards trying to address these issues through Shaping Safer Online Spaces

#### Conference on Feminist Technology | 1st – 8th August



As part of our capacity building initiative towards Shaping Safer Online Spaces, the Communication and Network Officer recently attended a fascinating conference of collectives working on Feminist Technology creating digital spaces that are inclusive and safe for all, especially women and non- binary persons. We learned a lot about the politics of Internet and how as safe abortion rights organization can we best optimize our network's internal communication and safety of our data, including inculcating certain practices which can be helpful in securing the privacy of our Youth Champions and Country Advocacy Networks, as well as of those who reach out to us.





Women are still shamed and made to feel guilty after giving birth to a girl child, and often subjected to violence and/or abandonment.

Neglect and discrimination of girl children continues as well resulting in a **higher death rate for the girl** children below six years of age, even as the policy and programme efforts are on to ensure that more of them are being born.

> The conversation and rhetoric around sex ratio became more visible and mainstreamed in the 1990s.

> Unfortunately this resulted in making the sex ratio a priority as a number to be 'fixed' and deflected attention from the core issue of gender-based discrimination which is the reason why daughters are unwanted and sons are desired in India.

#### Abortion SCI A way still lacks a India's abortion law still lacks a rights-based approach, gynecologist says

India's abortion law is progressive but it is also problematic, says Dr. Suchitra Dalvie, a practicing gynecologist in Mumbai, India. The co-founder and coordinator of the Asia Safe Abortion Partnership unpacked the law and recent amendments to it with The World's reporter Chhavi Sachdev.

"I recognized that when you really unpack the various layers of patriarchy, all the oppressive frameworks of patriarchy, the core of it really is the need to control women's sexuality. Because unless you can make sure that a particular woman has sex only with her husband, and that too, only after marriage, there was no way in the earlier days to ensure that the son she bears is that of the man.Right from the high premium on virginity before marriage, to the kinds of controls on women's mobility on their work, on their education, the entire focus is to make sure that you're a good wife, and therefore, eventually, a good mother. And in the context of some countries like India, Nepal, Vietnam and China, the whole sex ratio issue is not just about being a mother, it's about being a mother to a son."

#### Abortion Is Legal In India But Rules, Stigma Make It Hard To Access



""There is a very strong stigma attached to abortion, which emerges from sociocultural notions and the glorification of motherhood," Suchitra Dalvie, a gynaecologist and coordinator of Asia Safe Abortion Partnership (ASAP) told Behanbox. "As a result, it is seen as something that 'good women' won't do."

"This stigma affects the thinking of medical practitioners as well, said Dalvie. "Just because there is an abortion law in the country does not mean all gynaecologists are pro-choice," she said. "Medical education is very much about biomedical training and does not incorporate gender rights or the socio-cultural context [of medical practice]."

#### Activists hail SC judgment stressing on rightsbased perspective for women to seek abortion

The judgement also clarifies that MTP should be accessible to not just cis-gender women, but also to persons who may require access to safe medical termination of their pregnancies



"It's an incredibly powerful ruling that will go a long way towards ensuring autonomy, agency and bodily integrity and rights for all girls, women and pregnant persons,"



""[There is ] the deeply entrenched patriarchal environment in which motherhood is glorified, in which marriage is seen as sort of compulsory, and there is this general feeling that abortion is not a good thing. We then have a medical system which is fairly misogynistic and is not very supportive of women from the point of view of their rights, agency, and dignity. So, a lot of women are treated badly and even cruelly when they come for abortions." There is also a lot of coercion for contraception, she added."




